The Council of Caribbean Associations - Canada (CCAC) is a registered non-profit umbrella organization comprising of registered national Associations of Caribbean countries.

The registered member associations include Alliance of Guyanese Canadian Organizations; Antigua & Barbuda Association of Toronto; Association of Bahamians in Canada; Barbados Independence Celebrations Committee; Commonwealth of Dominica, Ontario Association; Grenada Association (Toronto); La Maison d'Haiti du Grand Toronto; Jamaica Diaspora Canada Foundation; Montserrat Association (Toronto); NevCan Cultural Association; St. Kitts & Nevis Association of Toronto; St. Lucia Toronto Association; St. Vincent and the Grenadines Association of Toronto and Trinidad & Tobago Association of Ontario.

Launched in 2009; the organization aims at among other things; to work with other organizations in our community that represent and cater primarily to people of Caribbean descent who have made Canada their home. CCAC initially focused on three major areas (1) to assist young persons in their pursuit of higher learning and sustainable employment; (2) to work with our seniors to better provide them vital information to enhance their productivity in the golden years; and (3) to undertake a disaster preparedness program that provides outreach and guidance when disasters strike the Caribbean. CCAC has since assigned disaster preparedness to another organization, Canadian Caribbean Disaster Relief Action (CCaDiRA).
